(I) Valid Class 'A' Electrical Contractor's Licence (HT) issued by the competent authority in favour of Tender and must have registered themselves with Electricity Department, Daman prior to award of contract.

(II) The bidder participating in this tender must have adequate experience for last 3 years of Supply testing & commissioning of at least one No. 66/11KV, 10 MVA sub station with civil works and erection of 66 KV transmission lines. The required documents from the concerned authorities for successful completion of the works may be furnished. The sub station must be in running condition successfully for minimum last 2 years on due date of bid opening for which necessary certificate has to be enclosed.

(III) The contractor must have annual turn over of Rs.10 Crores for past 3 years and produce a solvency certificate from the Schedule Bank of Rs. 1 Crore

(IV) Any agency who has been banned for malpractices or poor performance or for any other reason either by this department or any other department organization need not bid as such bids are liable to be rejected as and when it comes to light.


