

Terms and Condition of Appointment :-

1. The appointment is purely on Temporary Work Charged basis and liable to be terminated at any time without any notice.
2. The appointment is pure on Temporary Work Charged basis and services rendered on NMR prior to appointment on Work Charge Establishment should not be counted for any regular post in future in the Govt.
3. They will have to report for duty within a week period from the date of receipt of this order failing which his/her appointment shall be treated as cancelled.
4. They will have to produce physical fitness certificate from the Chief Medical Officer, Daman before joining duties.
5. They will have to take an oath allegiance to the constitution of India in the prescribed form.
6. They will have to produce character certificate from two Gazetted officers or from Magistrate of first Class or any Executive Magistrate before joining duties.
7. They will have to produce original birth certificate and education qualification certificate before joining duty.
8. They will not be entitled for pension benefit and all the incumbents have to submit an undertaking stating that they will refund any excess payment that may be found to have been made as a result of incorrect fixation of pay or any excess payment detected in the light of discrepancies before resigning the post. He/She will be liable to relinquish his/her post only when his/her resignation is accepted and is relieved from the service.
9. This order is valid upto 31/03/2014 and post will be further continue subject to the approval of the competent authority every financial year.
10. An incumbent on the post created specific period will be required to vacate the post on complete of tenure of the post unless otherwise the post is further extended he/she will be no right on permanent post.
11. They will be entitled for consolidated salary as per the pay scale shown against their name.
12. They are not entitled to get any benefit of CPF/GPF.
13. They will discharge their duties where they are at present working, no separate order for assignment of duty will be issued.
