NOTIFICATION

In exercise of the powers conferred by the provision to Article 309 of the Constitution, read with the Government of India, Ministry of External Affairs Notification No.F.7(11)/62/GOA dated 25th July, 1963 and Department of Pers.& Trg., O.M. No.A-B/14017/2/97-Estt(RR) dt. 25/5/1998, and in supersession of the existing Recruitment Rules for the posts and all other powers enabling him in this behalf, the Administrator of Daman and Diu hereby makes the following rules relating to recruitment to Group 'C' and Group 'D' (Non-Gazetted Non-Ministerial) posts in the Electricity Department under the Administration of Daman & Diu namely:

(1) Short title and Commencement:

- (i) These rules may be called The Administration of Daman and Diu, Electricity Department Group 'C' & 'D' (Non-Gazetted-Non-Ministerial) Posts Recruitment Rules 2000.
- (ii) These rules shall apply to the post specified in column 1 of the schedule to these Rules (here in after called as the said Schedule), and they shall come into force on the date of their publication in the Official Gazette.

(2) Number of posts, classification and Scale of Pay: The number of posts, its classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.

(3) Method of Recruitment, age limit and other qualification, etc.: Method of Recruitment, age limit qualifications and other matters relating to the said posts shall be as specified in columns 5 to 14 of the said Schedule.

(4) Disqualifications: No person (a) who has entered into or contracted a marriage with a person having a spouse living, or (b) who, having spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts. Provided, that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other ground for so doing exempt any person from the operation of this rule.

(5) Power to relax: Where the Administrator is of the opinion that, it is necessary or expedient so to do, it may by order and for reasons to be recorded in writing, relax any of the provision of these rules with respect to any class or category of persons.

(6) Saving: Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes and Scheduled Tribes, Other Backward Class, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
